- 23 shares rose and 72 fell with FABL PA (+7.99%), HBL PA (+1.3%), and SYS PA (+1.14%) the biggest contributors to index gains
- FFC PA (-2.28%), MCB PA (-1.87%) and PPL PA (-1.9%) were the largest index drags
- Monday was the start of the PSX's gradual enhancement of security wise circuit breakers by 0.5% on a fortnightly basis till they reach 10%. W.e.f 27th May, 2024 circuit breakers were enhanced to +/-8% or PKR 1 whichever is higher for the next two weeks
- While maintaining a positive outlook on the market we are cognizant of the downside potential should important support levels give way
- This week should prove to be decisive concerning market direction
