- Following an above consensus rate cut of 150bps the market gapped up and extended to +0.8% DoD before turning lower to close -0.87% on the day.
- 24 shares rose while 68 fell with SYS PA (-3.12%), MEBL PA (-2.01%) and MARI PA (-2.35%) were the biggest downside contributors.
- Last Friday's lows are now under threat as the market draws to the 70k level.
- Post Budget once the dust settles, opportunities to buy a deeply oversold market will be presented.
