

- As Asian rebounded Pakistan didn't participate and close flat on the day
- 45 shares rose while 48 fell with HUBC PA (+0.93%), MEBL PA (+1.12%) and SYS PA (+1.6%) were the biggest contributors to index gains
- LUCK PA (-1.64%), PSO PA (-1.76%) and BAFL PA (-0.79%) were the biggest index drags
- The Chinese auto giant BYD is set to make its official entry into the Pakistani market, with a launch scheduled for August 17th. The world's leading New Energy Vehicle (NEV) manufacturer has partnered with Mega Motor Company, a subsidiary of HUBC PA, to introduce its range of electric and plug-in hybrid vehicles
- Until the KSE-100 can regain 78k lower levels are likely
