- Intra day gains moved beyond 79k but the close remained below
- 35 shares rose while 63 fell with UBL PA (+3.01%), KOHC PA (+9.45%) and MCB PA (+1.54%) the biggest index contributors
- MARI PA (-1.62%), BAHL PA (-1.44%) and HUBC PA (-0.61%) were the largest index drags
- KOHC PA (+9.45%) announced FY24 EPS: PKR 45.41, +53% YoY, 4QFY24 EPS: PKR 12.16, +5x YoY. Along with the result, the company announced a buyback of up to 12mn ordinary shares (6% of the total outstanding shares and 20% of the total free-float which will commence from 23rd Oct'24 to 12th Apr'25
- Domestic cement sales in August fell -27.5% YoY to 2.75 million tons
- The SBP is scheduled to announce its monetary policy on September 12, 2024. We anticipate a 150bps cut, bringing the policy rate down to 18%— a level last seen in Feb'23, when it had dropped to 17%.
- The KSE-100 is currently +0.5% WoW heading into the last session of the week and a +79k close sets up moves to 80k
