- Mixed start to the week with supply spilling over from Friday.
- 55 shares rose while 43 fell HUBC PA (+1.18%), EFERT PA (+0.72%) and MARI PA (+5.83%) had the biggest upside contributions to the index while MEBL PA (-1.09%), DGKC PA (-4.56%) and UBL PA (-0.58%) were the largest index drags.
- DGKC PA FY24 EPS: 1.24 vs LPS -8.3 in the SPLY, the result was below expectations of 7.06 and the stock sold off as a result.
- Buyers of the rate cut last week remains underwater and once the excess supply is absorbed the market should resume its advance.
- Initial support is @ 79k and we will maintain a positive outlook on the market above key support @ 78k.
